



## GUEST Pet Policies

- Upon check-in pets must be properly immunized and you must present your pet's shot records
- Cats and Dogs are allowed. No exotic animals will be allowed to stay at lodging
- There is a \$10 per night fee in addition to other lodging rates
- There may be additional cleaning fees if your pet damages furniture or defecates/urinates in the room
- Secure your pet in the pet cage provided for you or in your own pet container when not in the room
- Do not leave a "DO NOT DISTURB" sign on your door
- Housekeeping will enter your room daily for cleaning
- Pets are not allowed to sit directly on furniture or bedding
- Owners may not use lodging towels or linens to bathe pets
- Pets are not allowed in any other rooms, facilities, or premises
- Each pet must have a collar with your name on it and must be leashed when outside the facility
- If your dog(s) continually barks and disturbs other guests, you may be asked to kennel your dog(s)
- Owners are required to clean-up/pick-up their pet's waste and dispose properly
- Infraction of rules may result in removal of you and your pet(s) from lodging

## PET FRIENDLY TLF UNIT INSPECTION CHECKLIST

1. Guest checking-in/out during normal duty hours (0730-1630) Guest will be accompanied by a lodging inspector to perform a TLF unit inspection utilizing black light procedures.

All room and furnishings discrepancies must be annotated by the inspector and guest to ensure that any charges which may be applied to a guest account are accurate and legitimate.

2 Guest checking in after normal duty hours All pet friendly TLF units will be inspected daily by a lodging inspector utilizing black light procedures and a pet-friendly TLF checklist. The front desk will maintain copies of these inspections and will issue one to you upon check-in after normal duty hours.

You as the guest will be required to perform a self-inspection when you enter the room. Any room or furnishings inspection discrepancy must be addressed to the front desk or lodging management no later than 0900 the following day. As soon as possible a lodging inspector will meet with the guest and clarify any discrepancy.

3. Guest checking out before normal duty hours. Guest will notify the front desk of any damages that may have occurred to their TLF room.

As soon as possible, a lodging inspector will inspect the room and utilize black light procedures. If damages occurred that were or were not reported, charges may be charged to the guest credit card on file.

**Guest must acknowledge this agreement prior to checking in.**

## Pet Friendly Rate

The family TLF units that will hold the pets are \$41.50 a night and with the \$10 fee per night the actual price for the Pet friendly room is \$51.50
