

EXPANDED CHILD CARE PROGRAMS

- **Medical Care** provides care for medical emergencies and have no one else in the home available to provide care.
- **Wounded Warrior Care** provides hourly care for appointments and have no one else in the home available to provide care.
- **Bereavement Care** provides hourly care for appointments for a fallen military family member and have no one else in the home available to provide care.

AIR FORCE AID SOCIETY PROGRAMS

Please contact the A&FRC at 919.722.1123 to set up the following FREE care

- **Child Care for PCS** provides child care to eligible members' permanently changing location. The family will receive up to 20 hours of child care (for each child) when you are within 60 days of your PCS departure or arrival date at this base. It is the responsibility of the family to ensure the 20 hour limit is not exceeded. Contact providers directly to set up care.
- The **Volunteer Program (VP)** provides 20 hours of child care to anyone who volunteers with approved programs. Contact providers directly to set up care.
- The **Key Spouse Initial Training Program** provides care for those spouses attending training to become a Key Spouse to support their squadron.

Who Can Become a Family Child Care Provider?

You must be at least 18 years old with a high school diploma/GED and have the ability to read, write, and speak English. All applicants will be screened through various state, federal and Air Force agencies to determine suitability for child care.

FCC accepts children, staff, and providers with chronic health problems.

Priority given to new providers willing to provide EDC, evenings/weekends, and infant care.

The Diversity of Family Child Care

The Air Force Child Development Programs play a significant role in supporting mission readiness and increasing the retention rate of Airmen. These programs include the Child Development Center (CDC), the School Age Care Program (SAC), and the Family Child Care Program (FCC).

SJAFB's Family Child Care (FCC) program features specially trained and licensed providers who offer in-home care both on base and in approved affiliated homes. These professionals have age-appropriate toys, educational materials, and safety items provided by the 4th FSS Family Child Care Resource Library. Children in the program range from 2 weeks to 12 years of age.

The FCC Coordinator supports the program by ensuring child care providers at SJAFB are screened, trained, and licensed to provide child care. The FCC Coordinator monitors the homes and conducts unannounced inspections monthly. These inspections are conducted through all providers operating hours (including extended duty and weekends).

The FCC program accepts children for care who have chronic health challenges, developmental delays, and children who are HIV+.

One of the hallmarks of the FCC program is its ability to tailor care to the unique needs of military families.

Who are Family Child Care Providers?

A Family Child Care Provider is an individual who is licensed by the Air Force to provide home-based child care for children on a regular basis.

Family Child Care homes provide child care on a regular basis to one or more children for more than 10 hours a week. Any other regular child care over 10 hours a week is illegal if not licensed.

Family Child Care Opportunities:

A realistic alternative to the Child Development Center (CDC). Providers are fully trained as CDC providers, and offer full-time, part-time, hourly, before & after school, nights, weekends, return home, extended duty, and PCS care.

EXPANDED CHILD CARE PROGRAMS

Please contact FCC Office to arrange for the following FREE care opportunities:

- **Extended Duty Care (EDC)** is designed to help families who have a requirement to work longer hours, evenings, overnight, weekends, and/or are experiencing a temporary shift change (up to 3 days) while they perform their mission during contingency or high tempo operations and have no one else in the home available to provide care.
- **Returning Home Care (RHC)** offers up to 16 hours of child care to eligible members returning from a 30+ deployment in support of contingency operations as well as those returning for their 2-week Rest & Recuperation (R&R) leave.
- **Pre-Deployment Care (PDCC)** offers up to 16 hours of care per child for those Active Duty, National Guard, and Reserve members assigned to an Air Force or Joint Base (Air Force led) installation prior to deploying in support of contingency operations for more than 30 days.
- **Deployment Care (DCC)** offers up to 16 hours of care per child for those Active Duty, National Guard, and Reserve members assigned to an Air Force or Joint Base (Air Force led) installation deployment in support of contingency operations for more than 30 days.
- **Home Community Care (HCC)** provides care during primary UTA weekends and there is no one else in the home available to provide care for ANG and AFR.
